## **DEAR FRIENDS, COLLEAGUES, AND PARTNERS!**

Another challenging week is behind. With President Volodymyr Zelenskyy, we visited Kupiansk and held a meeting on the operational situation in the region. There were reports on the Kupiansk sector and other defense issues.

Special attention was paid to humanitarian challenges. In particular, during the heating season in the frontline communities, it is essential to provide

people with heat, water, and electricity despite the constant shelling.

We are working with regional and local authorities to provide alternative energy sources to the frontline areas.

The heating season is underway in Ukraine. On November 17, russia made a massive missile attack across Ukraine and damaged the critical infrastructure of

the Volyn, Lviv, Odesa, and Vinnytsia regions.

The enemy targeted energy facilities to leave Ukrainians without heat, water, and electricity. russian will not stop trying to destroy critical infrastructure; our goal is to create a sustainable generation system. We are in touch with community leaders, regional military administrations, and the government.




#### **CRISIS IN KRYVYI RIH**

In the Dnipro region, an emergency meeting of the Headquarters is held to prepare housing and communal services and the fuel and energy sector for the winter period of 2024/25. The headquarters gathered in Kryvyi Rih, where 934 residential buildings, 11 hospitals, and 43 educational institutions, with more than 130 thousand consumers, are currently without heating.

The Ministry for Development appealed to the Security Service of Ukraine and the Ministry of Internal Affairs of Ukraine regarding the disruption of the heating season in Kryvyi Rih.

I heard reports from the city and regional authorities, Naftogaz, Kryvyi Rih CHP, and the State Energy Supervision Service on the reasons for the critical situation. I also invited representatives of law enforcement agencies to the meeting. We must now do everything possible to resolve the problem immediately. Such a situation



is unacceptable in any city or region of the country. In the face of constant shelling, we must think about providing people with basic living services. Repair works are currently underway in Kryvyi Rih.

The situation is expected to be normalized within a week.

#### LATVIA ==

I was glad to meet with the Latvian Ambassador to Ukraine, Ilgvars Kļava. We are grateful to the Republic of Latvia for its cooperation and constant support of our country. This exemplifies the concrete work we have been doing calmly and carefully for years. On behalf of the entire Chernihiv region and the Ministry, I sincerely thank you for all the help you provide.

We already have several priority areas in which we want to continue our cooperation. Of course, first and foremost, it is the support of our frontline regions and the protection of energy facilities.



#### ITALY

Last week we met with the Ambassador of Italy to Ukraine Carlo Formosa and discussed Italy's plans to implement specific reconstruction projects in the Odesa region.

I thanked the Italian partners for their willingness to cooperate and help Ukraine in times of war, outlined priorities and joint plans to

address the priority needs of Ukraine identified by the Government, and invited them to participate in the Congress of Local and Regional Authorities under the President of Ukraine.

We are forming a significant portfolio of projects with the participation of Italy. It includes the social sphere's construction, agriculture developments, and cultural restoration initiatives. We

are now planning to hold technical meetings and agree on details.

Carlo Formosa said that all implementing projects are in line with the priorities of the Ministry for Development. Earlier, in a joint Ukrainian-Italian Communiqué, Italy announced that it would take patronage of the Odesa region's reconstruction to speed up its recovery from the consequences of russian aggression.





#### WORLD BANK THE WORLD BANK



During the meeting with the Managing Director of Operations at the World Bank, Anna Bjerde, we discussed support projects for the frontline regions and expanding measures to protect energy infra-

structure. We discussed the preparation of RDNA4. Particular attention was paid to the issue of public investment management.

We support the World Bank's initiative to create a mechanism for developing

economically sound investment projects that meet the country's goals - the Ukraine Project Preparation Framework (PPF).

I thanked the World Bank for supporting Ukraine during the war.



## NEW RAILWAY ROUTES TO THE EU

Starting December 15, the route from Kyiv to Bratislava, Slovakia, will be operated by the train Kyiv - Chop - Kyiv and the new train of the Slovak Railways Chop - Bratislava - Chop. This is another step towards Ukraine's integration into the

European Union. We continue to modernize the existing infrastructure and develop rolling stock. I am grateful to the team of Ukrzaliznytsia, the Government, and international partners for the great work done.

The international connection between the capitals of Ukraine and Slovakia aims to

connect Kyiv, Lviv, and Mukachevo with Bratislava and other major cities in neighboring Slovakia (Kosice, Žilina, Trnava, Trencin, Poprad).

This route was launched as part of the agreements between the governments of Ukraine and Slovakia on infrastructure and logistics development.



#### **REGIONS DEVELOPMENT**

We are preparing an updated Concept for reforming local self-government and territorial organization of power in Ukraine. The decentralization reform in Ukraine is one of the most effective in Ukraine. According to research by the Council of Europe, 77% of Ukrainians believe that the reform of self-government and territorial organization of power should continue. The success of decentralization is also highly appreciated by international experts and partners.

Despite daily challenges, the war and decentralization reform have lasted for ten years. This is our unique experience, which does not exist in any other country. Thanks to the reform, at the beginning of the full-scale invasion, Ukrainian communities became the basis of resistance against the russian aggressor. The communities continue to be resilient and robust in restoration and development.

Last week Ukrainians commemorated 1000 days

since the russian full-scale invasion and the Day of Dignity and Freedom which are the important milestones in the modern history of Ukraine on its way to the European Union. Thanks to all the partners who stay on the side of light, Ukraine continues to fight for its future.



#### **RESTORATION PROJECTS: DREAM ANALYTICS\*\***

The Digital Restoration Ecosystem for Accountable Management (DREAM) is a significant milestone in Ukraine's restoration efforts. It's not just a state digital platform for implementing restoration projects but a powerful tool that underscores our unwavering commitment to transparency and accountability.

8515 projects have been added to DREAM since the launch of its beta testing in September 2023. The number of projects by sector includes:
3259 projects created in the Education sector
1215 projects created in the Healthcare sector
946 projects created in the Water, Sanitation, and Waste management sector
834 projects created in the Housing sector
749 projects created in the Transport sector

### **STATE BUDGET 2025**



The Verkhovna Rada of Ukraine adopted the State Budget for 2025

The state budget expenditures are planned to amount to over UAH 3.6 trillion, which is UAH 535 billion more than this year. More than UAH 2.2 trillion (about 26% of GDP) will be allocated for security and defense.

To support the communities, the personal income tax (PIT) paid in the respective territory of Ukraine remains at 64%. In addition, no reverse subsidies will be transferred from the territories' budgets where active hostilities have been or are being conducted to the state budget.

#### THE BUDGET FOR 2025 ALSO PROVIDES FOR FUNDING FOR:

- The State Regional
   Development Fund —
   UAH 1 billion
- eVidnovlennia UAH 3 billion for the compensation program for destroyed housing and UAH 1 billion for damaged property
- Railway infrastructure facilities: renewal of rolling stock for passenger

- transportation, construction and reconstruction infrastructure – UAH 4.4 billion
- The civil aviation: ensuring the functioning of critical infrastructure operators in the sector – UAH 0.8 billion

The State Agency for Restoration and Infrastructure Development of Ukraine is provided with funding for:

- maintenance of roads (including the military and evacuation needs) – UAH 12.6 billion
- construction of main water pipelines to supply water to Mykolaiv to overcome the consequences of russian blowing up of the Kakhovka HPP –
   UAH 8 billion.



The state budget for the next year also features introducing a new approach to public investment management (PIM). Its goal is to use budget funds efficiently, directing them to the most important projects that meet the country's strategic goals during the war. The DREAM ecosystem has assembled the Single Project Pipeline, which includes 787 projects worth UAH 2.6 trillion. Funding for UAH 224.2 billion has already been allocated for 2025 to implement the highest-priority projects.

### THE MINISTRY AND WORLD BANK DISCUSSED RDNA 4

The Ministry for Development and the World Bank discussed the preparation of an updated assessment of Ukraine's needs for recovery and reconstruction of RDNA4

The topics of the talks included preparing the updated Ukraine Rapid Damage and Needs Assessment (RDNA4). The document will serve as the basis for the formation of priority reconstruction and

development projects, with the involvement of public and private funding. Particular attention was paid to the issue of public investment management.

The Ministry for Development paid attention to the issue of public investment management. The Ministry support the World Bank's initiative to create a mechanism for developing eco-

nomically sound investment projects that align with the country's goals - the Ukraine Project Preparation Framework (PPF).

The parties discussed support projects for frontline regions – where people need it most, as well as the expansion of projects to protect energy infrastructure. And also focused on supporting internally displaced persons and building housing for them.

## LATVIA SUPPORTS RESTORATION PROJECTS IN UKRAINE

Latvia to expand support for Chernihiv region recovery projects next year

Latvia remains a reliable and constant partner for Ukraine. Next year, cooperation between the two countries will develop in several areas, including restoring the Chernihiv region, developing transport links, and developing energy security.

This was agreed upon during a meeting of Oleksii Kuleba, Deputy Prime Minister for Restoration of Ukraine with Ilgvars Kļava, Ambassador of Latvia to Ukraine.

Tymur Tkachenko, Deputy Minister, noted that Ukraine is interested in developing transport logistics and access to the Baltic ports.

Deputy Minister Maryna Denysiuk invited Latvian partners to join the Operational Group established under the Ukrainian Donors Platform and an Advisory Group under the Agency for Restoration.

Both groups will help coordinate and specify recovery projects. The Operational Group will be a "one-stop shop" for sharing information on urgent recovery and reconstruction needs.





The two sides agreed to synchronize their efforts to rebuild the Chernihiv region. Ilgvārs Kļava assured that in 2025 Latvia will continue to allocate funds to help Ukraine. The focus remains on social sector buildings, such as schools, hospitals, and nongovernmental organizations.

According to the ambassador, Latvia needs to make the lives of Chernihiv residents affected by the war more comfortable. That is why many Latvian volunteers are currently working to help the region. In addition, Latvian energy companies have expressed a desire to provide solar panels for Chernihiv Oblast. The issue of their delivery and installation is currently being resolved.

transferred to water utilities,
where they will be much more
efficient.

Access to Latvia's port infrastructure is only possible via transit rail service through Poland. Therefore, there is a need to build new terminals to switch wagons to bogies of a different gauge.

The implementation of this project will create an alternative transportation corridor and allow for the formation of a new supply chain.

This, in turn, will increase the volume of cargo transportation and open access for Ukrainian exporters to the port facilities of the Baltic countries.



## **UKRAINE FACILITY PLAN IMPLEMENTATION MONITORING**



support for public investment management reform. The Single Project Pipeline must include all projects involving capital expenditures. This will increase the capacity to attract investment at both the national and local levels.



Maryna DENYSIUK, Deputy Minister for Development of Communities and Territories of Ukraine:


From the beginning of the Ukraine Facility, I was part of the team of experts that developed and launched it. I continue to coordinate the plan's implementation regarding indicators and Pillar 2 with the European Commission.

This example demonstrates the consistent approach of the Ukrainian Government, which increases the level of trust in Ukraine on the part of its partners. In addition, preserving and transferring institutional memory contributes to more effectively implementing the necessary reforms.

During the meeting, she emphasized that the Ministry's experts are constantly monitoring the implementation of the indicators of the Ukraine Plan, as well as the recommendations of the European Commission, as defined in the annual Enlargement Report.

## **REGIONS DEVELOPMENT OF UKRAINE**

Deputy Minister Oleksii Riabykin took part in the political-level meeting of the European Alliance of Cities and Regions for the Reconstruction of Ukraine.



The Ministry for Development of Communities and Territories of Ukraine is currently focusing significant efforts on integrated regional development, with an additional focus on rebuilding housing for internally displaced persons and building social and critical infrastructure.

The upcoming URC2025 Ukraine Recovery Conference to be held in Rome should focus on strengthening the capacity and role of communities in the implementation of recovery projects, allocation of financial resources, and implementation reforms.

The Deputy Minister emphasized that on the eve of the event in Rome, the Government of Ukraine continues to work on a number of reforms. In particular, the decentralization reform, the process of strengthening the role of communities in the recovery and reconstruction processes, and the reintegration of the temporarily occupied territories and internally displaced persons are ongoing.

Oleksii Riabykin noted that in preparation for URC2025, the Ministry for Development plans to hold a thematic event with representatives of local governments, regional state administrations, and development partners (pre-

URC). He took this opportunity to invite the Committee and the Alliance to join the event.

During the political level meeting of the European Alliance of Cities and Regions, the Declaration of Support for the Local and Regional Dimension in the Reconstruction of our Country was approved. The Alliance will continue to work to strengthen partnerships, share knowledge, and empower Ukrainian local and regional governments on their path to EU membership.

This meeting will be a milestone between the Ukraine Recovery Conference 2024 (URC2024) and URC 2025, which aims to demonstrate progress in reform implementation and mobilize international support for Ukraine's recovery. Like last year, the regional and local dimensions will be one of the four main focus areas at URC2025, reflecting the key role of communities and regions in the recovery and Ukraine's path to the EU.

# REFORM AND RECOVERY SUPPORT TEAM STEERING COMMITTEE

On November 20, a meeting of the Steering Committee dedicated to the results of the implementation of the Recovery and Reform Architecture in Ukraine (URA) program in Ukraine was held, the participants of which discussed the results of the work and further plans of the Recovery and Reform Support Team under the Ministry for Development of Communities and Territories of Ukraine.



The working meeting was attended by Deputy Ministers Maryna Denysiuk, Oleksii Riabykin, and Anatolii Komirnyi, Deputy Head of the EBRD Delegation in Ukraine Iryna Kravchenko, Head of the Reconstruction, Energy, Infrastructure and Environment Unit of the EU Delegation to Ukraine Jocelyn Cornet and the Director of the Recovery and Reform Support Team at the Ministry for Development Anatolii Timenko. Maryna Denysiuk expressed gratitude to the partners

for their leadership and unwavering support of Ukraine during Russia's military aggression.

The Deputy Minister also emphasized the importance of cooperation with the Team within the framework of the URA program. In particular, she noted the Team's contribution to preparing and implementing important regulations on Ukraine's path to integration with the EU.

The Deputy Minister also added that the reform

of public investment management (PIM) is currently underway, which is a priority and a priority.

The purpose of the reform is to create a holistic, sustainable, and effective management system that will ensure the planning of investment projects by strategic priorities and medium-term budget frameworks, their selection according to uniform, transparent procedures and clear criteria, as well as their timely implementation within the planned timeframe.





According to Deputy Minister Oleksii Riabykin, the Ministry team fundamentally supports the activities of the Recovery and Reform Support Team. It seeks to expand and strengthen our cooperation per the wartime requirements. First, this concerns the reform of decentralization and the reintegration of temporarily occupied territories. We perceive the temporarily occupied territories as a separate macro-region

with needs, challenges, and tasks that must be effectively addressed. We have a lot of work ahead of us, so we continue to work for results.


Deputy Minister and CDTO

digital projects developed by
the Ministry. This applies to
the Register of Damaged and
Destroyed Property launch,

the urban planning cadastre, the eQueue project, etc.
There needs to be more than just launching any electronic service at the state level to develop a digital product. Much work must be done to amend the legislation to legalize the service and protect the product properly. That is why technical support from RST experts and project managers is very important in regulating all procedures.




Donors noted that it is important for them to work with the ministry as the most attentive institution in implementing recovery. Considering PIM's investment policy, they also understand the need to expand the team.

For his part, the Director of the Team, Anatolii Timenko, spoke in detail about the achievements and most important developments of the Team over the past year, as well as outlined plans and priorities of work. In particular, the central area of work is implementing EU law to Ukrainian legislation within the defined reform priorities and indicators of the Plan of Ukraine.

## **ENERGY EFFICIENCY – GREEN DIM PROGRAM**

The Energy Efficiency Fund has already received 100 applications for participation in the Green DIM program

The potential threat of blackouts has become a powerful incentive for condominiums to protect themselves, especially during the 2024-2025 heating season. Co-owners are looking for ways to guarantee the energy independence of their buildings to ensure the uninterrupted operation of critical utilities: lighting, elevators, and pumps for water and heat supply.

A program from the Energy Efficiency Fund, Green DIM, which provides grants to condominiums across Ukraine, helps to implement such tasks. The leading regions in terms of the number of applications:


• 40 – Kyiv region

• 22 – Lviv region

• 9 – Mykolaiv region

•8 - Rivne region

• 6 - Dnipro region



Most applications involve the installation of solar power plants (SPPs).
This solution ensures partial energy independence of buildings and avoids extended power outages.
Using solar power plants also significantly reduces the cost of maintaining buildings, including electricity.

The number of applications for participation in the Green DIM Program is growing monthly. This demonstrates the interest of condominiums in implementing alternative energy projects.


The total cost of the submitted projects as of November 18, 2024, is UAH 146.864 million, and the expected amount of grants is UAH 97.242 million.

Thanks to the Green DIM Program, SPPs with a total capacity of 2.8 MW will be installed, reducing electricity consumption by 3.4 GW, more than UAH 13.07 million in cost savings.

Currently, the Energy
Efficiency Fund has the
potential to support
several hundred more
projects to install alternative
energy sources, which
will help thousands of
Ukrainians go through the
2024–2025 heating season
without complications
and save significant
money on building
maintenance.
