EUROPEAN INTEGRATION, INTERNATIONAL COOPERATION, TOURISM AND ENERGY EFFICIENCY



In 2024, the Ministry for Development of Communities and Territories of Ukraine paid special attention to European integration, work with international recovery partners, community cooperation, and energy efficiency.

This year's priority was also to strengthen and develop international cooperation, both at the governmental level and at the level of communities and regions. New partnerships must emerge between Ukraine's cities and regions and foreign countries, which will now cooperate on recovery and many other projects.

Thanks to the efforts of the Ministry's team, we increased the volume of international support: in 2024, more than \$1 billion 115 million was raised for recovery and development projects.

Next year, we will continue cooperating with all international fi-


nancial organizations in the most important areas: restoration of critical infrastructure, distributed energy, and energy efficiency, restoration of housing, educational institutions and hospitals, and construction of shelters, focusing on frontline communities.

The main topic of the Ukraine Recovery Conference (URC) in July 2025 in Rome will be attracting international support for community recovery and development projects. We will focus on strengthening the capacity and role of communities and regions in the reconstruction process, allocating financial resources, reforms, and Ukraine's accession to the EU.

Any policy must focus on people's expectations and needs. Regional policy must have clear priorities, consistency and systematicity, and coherence with other policies. Most importantly, it must respond to society's demands.

Complex demands and problems that existed before and during almost

three years of full-scale invasion have become a real challenge for the state system and local governments, for every Ukrainian family, and for every Ukrainian. Ukraine has survived thanks to the unity of Ukrainians. In the face of a great war based on transparency and accountability, we must move forward and integrate into the European Union.

TRANSPORT AND POSTAL SERVICES

The Ministry for Development of Communities and Territories of Ukraine has introduced a number of innovations in the postal sector, increased the volume of rail and sea transportation, and adopted important regulations for the industry.



Despite continuous russian attacks, the year demonstrated dynamic progress in key areas. Improved regulatory frameworks have opened up new opportunities for postal operators to provide high-quality services. The Ministry is modernizing our internal systems and upgrading

our port and railway infrastructure. These steps have a positive impact on consumers and strengthen the Ukrainian economy.

Sustainable development in times of war results from practical cooperation with international partners, coordi-

nation of all stakeholders, and heroic efforts of the Ukrainian Armed Forces. The Ministry team is already working on European integration standards, and a number of projects for the next year have been launched in 2024.

International cooperation is the basis for consolidating efforts for recovery and development. The Ministry continues cooperating with global financial institutions, donors, and governments in partner countries to attract funding and technical assistance. In 2024,

we raised more than USD 1 billion 115 million for restoration and development projects. Together with partners, we reviewed all projects and updated their status. Every project has an implementation plan, and we are moving within the established terms.

This work is coordinated at the government level. Implementing the public investment management reform and forming a pilot Single-Project Pipeline based on the DREAM ecosystem is ongoing. All projects in the portfolio have been appropriately evaluated and verified. Next year, the plan is to move from the pilot phase to a systematic approach by creating

a methodological framework and introducing strategic planning for public investment. In 2024, the Ministry ensured the timely fulfillment of five indicators as part of implementing the Ukraine Facility Plan to ensure financial support for Ukraine from the European Union. We are preparing an updated RDNA4 - rapid damage and needs assessment report with the World Bank, the European Commission, and the United Nations. The document will serve as the basis for forming priority reconstruction and development projects involving public and private funding. We are paying special attention to the issue of public investment management.

HOUSING UTILITIES AND HEATING SEASON



In 2024, the Ministry for Development of Communities and Territories of Ukraine implemented a number of measures in the field of housing and communal services, preparation and passage of the heating season.

The coordinated work of the authorities at all levels and the cohesion of communities and regions ensured the start of the heating season in most regions of Ukraine in time.

Despite the russians constant attacks, the government responds promptly to challenges and restores utility infrastructure. For example, representatives of different communities and regions joined forces to restore the heating system in Kryvyi Rih.

Coordination in such circumstances is crucial, so the government headquarters was set up to prepare housing and utilities and the fuel and energy sector for the autumn-winter period of 2024/25. We have also established the Headquarters

for Cohesive Communities to inform about the heating season.

The main task of the Ministry remains to restore and develop the communal infrastructure in the context of the war. In particular, to introduce distributed generation, improve energy efficiency, and strengthen the energy independence of communities. Setting up a decentralized heating system is a top priority for every community in the face of constant russian shelling.

CONSTRUCTION AND HOUSING POLICY



2024 was a year of significant changes and achievements in construction and housing policy. Deputy Minister Natalia Kozlovska shared the main results in these areas.

Electronic systems, registries, and the automatic data

exchange between them are not only about transparency and overcoming corruption.

They also mean faster service delivery for individuals and legal entities in an automatic mode without officials' involvement. Thanks to digitalization, access to the necessary information is just a few clicks, both for the daily needs of every Ukrainian and for the strategic needs of communities.

ROAD TRANSPORTATION, BCP AND ANTI-CORRUPTION



In 2024 under the leadership of Deputy Minister for Development of Communities and Territories Serhii Derkach, significant positive changes were made in the field of road transportation, development of checkpoints, and building anti-corruption compliance in the Ministry's management.

Throughout the year, we worked as a team to ensure uninterrupted exports and imports of goods by road, liberalize transportation with other countries, improve bus travel abroad, and build checkpoints.

At the same time, we launched innovative projects to help overcome the challenges of the times,

such as the staffing crisis or queues at the borders. Today, we have a number of successful results in these areas, and we have even more work ahead of us to make the Ukrainian carrier competitive in the European market and to ensure that our citizens have the opportunity to use high-quality and safe transportation services.

THE MINISTRY FOR DEVELOPMENT PRIORITIES FOR 2025

2025 opens up new opportunities and identifies key areas for development. Key areas of Ministry work for 2025:

Energy security





Energy independence is one of the Ministry's main challenges in 2025.



Five hundred units of energy equipment are planned to be installed in communities, with a special focus on frontline settlements.

A pilot project for housing for internally displaced persons in communities is planned for 2025.

The implementation of the compensation program for damaged and destroyed housing eVidnovlennia continues. Thus, the State Budget 2025 provides UAH 4 billion for the eVidnovlennia program.

In addition, the Cabinet of Ministers of Ukraine has reallocated UAH 15 billion for damaged and destroyed housing compensation for internally displaced persons. The financial redirection of funds to the Ministry for Development of Communities and Territories of Ukraine is expected to occur in January 2025. These funds will be used

to compensate IDPs, both for existing certificates and certificates that will be issued in the future.

In 2025, a pilot project will be implemented to construct housing facilities for internally displaced persons in territorial communities. It is also planned to provide affordable housing for rent, including for IDPs.

Public Investment Management Reform



Public Investment Management Reform (PIM)

Implementation of public investment reform will continue at the state and local levels

The new Public Investment Management (PIM) Reform aims to use budget funds efficiently, directing them to the most important projects that meet the country's strategic goals in times of war. For 2025, funding for the Single Project Portfolio under PIM is envisaged in the amount of UAH 224.2 billion. Of these funds, UAH 115 billion will be raised under state

guarantees to restore critical infrastructure.

Over the next year, it is planned to continue implementing public investment reform at the state and local levels.

The Public Investment Management system emphasizes the critical role of strategic planning at the community level. Every community is

interested in developing and approving local development strategies. PIM provides communities with an effective tool for prioritizing and allocating resources to projects that meet strategic goals, especially during war. This approach guarantees transparency, accountability, and efficiency in using budget funds, contributing to each community's long-term development.

In 2025, communities will have access to the updated State Fund for Regional Development and the introduction of additional financial instruments for community development projects.

In addition, the State Strategy for Regional Development (SRD) will be updated regard-

ing the approval of functional types of territories and macroregions.

A new model for equalizing local budget revenues and a new model of community capacity will be introduced during the year. The Concept of Local Self-Government Reform will also be updated.

Decentralization reform is a component of the resilience of communities and the country. In 2025, we have to regulate the system of administrative supervision over the legality of local government decisions. Another important component of regional policy is the reintegration of the temporarily occupied territories.

National project "Hand in Hand"



The national project "Hand in Hand: Cohesive Communities" envisages cooperation of rear and more capable communities as a partner with frontline ones and those under constant russian fire outpost communities.

Cooperation in three key areas:



infrastructure restoration



humanitarian aid



cultural and social support.

More than 100 communities are currently involved in the project; another 114 outpost communities need support.

Regional policy and coordination of structural instruments

In 2025, together with the World Bank, the European Commission, and the United Nations, we will update the Recovery Needs Assessment Report - RDNA4.

The document will become the basis for the formation of priority reconstruction and development projects with the involvement of public and private funding.

Accelerating and deepening cooperation with the European Union. In 2024, the EU-Ukraine High-Level Transport Dialogue met for the first time in six years.

In addition, we have been actively involved in the

European integration process. The Ministry of Development has conducted a pre-screening analysis of adapting Ukrainian legislation to meet EU requirements in the key areas of transport and logistics.

In 2025, civil society will be involved in preparing, and bilateral EU-Ukraine meetings will be held as part of the official screening under Negotiating Chapters 14 "Transport Policy," 21 "Trans-European Networks," and 22 "Regional Policy and Coordination of Structural Instruments." Ukraine's negotiating positions on the relevant chapters will be formed simultaneously.

The Ukraine Facility is a program of financial support for Ukraine by European partners, which runs until 2027.

The Ukraine Facility envisages allocating €50 billion to support the budget, stimulate investment, and develop regional projects.

The Ministry for Development implements 26 indicators in the Ukraine Facility Plan and a co-implementer of two more. Thus, this year we managed to fulfill all 5 indicators mandatory for implementation in 2024. The Ministry has to meet eight more in 2025, 6 in 2026, and 7 in 2027.

Also, in 2024, the Ministry started working under the Ukraine Investment Framework (UIF or Pillar 2). The total volume of the UIF is €9.3 billion, of which €7.8 billion is the Ukrainian Guarantee, a special mechanism to protect investments during the war. The priorities for 2025 include investments in the energy sector. We must build additional capacities, decentralize the electricity and heat supply

system, and ensure community energy independence. The portfolio for 2025 will include regional projects in energy, water supply, heat supply, social housing construction, and assistance to small and medium-sized enterprises in the frontline regions.

A new Recovery and Reconstruction area is being created within the Ukrainian Donor Platform to become a single

window for coordinating and sharing information on urgent recovery and reconstruction needs. Depending on the agenda, the task force's meetings will be attended by government representatives, special envoys for recovery, platform members, HoCs, and other experts. The next meeting of the Ukrainian Donor Platform Steering Committee is scheduled for January 2025.

In 2025, it is planned to complete the construction of water intakes and main water pipelines to supply water to Mykolaiv. The water supply interruptions occurred as a result of the blowing up of the Kakhovka HPP dam by russian terrorists. The state budget for 2025 provides UAH 8 billion for these purposes. In addition, the Ministry is focused on

protecting energy facilities and building a cogeneration network. It also aims to restore facilities damaged by the war, attracting international support.



The eQueue project will continue to develop in 2025. In particular, as part of the new stage of the project's development, it is planned to scale the service to all types of vehicles crossing the border (cars and trucks less than 7.5 tons) to ensure automatic verification of certain information at the time of registration in the system, such as the availability of an insurance policy ("green card"), etc.

Special attention will be paid to implementing the Geographic Information System for Monitoring Regional Development (GIS RD) and developing the DREAM ecosystem, as well

The government plans to introduce the einspector system as part of the transport reform. This system will make the work of the State Service of Ukraine for Transport Safety more transparent. In addition, the distribution of European Conference of Ministers of Transport (ECMT) permits will be modernized. The exchange with customs will be finalized, and the rules for distribution and redistribution will minimize any human factor.

New digital solutions for the maritime industry are being prepared for 2025. In the first half of 2025, the long-awaited functionality of obtaining a seafarer's identity card will be digitized.

Export and military logistics



To ensure efficient logistics, particularly in the frontline regions, and evacuation routes, the Ministry envisages the following initiatives:



Repair and maintenance of roads: **UAH 12.6 billion** has been allocated for 2025, primarily for military logistics.



Development of automobile checkpoints, including infrastructure modernization for faster border crossing.



Strengthening security measures.

The priorities for 2025 include continuing the strategic work to restore Ukraine, which aims to support communities, improve living conditions

for IDPs, restore critical infrastructure, and attract international funding.

Implementing these tasks will become the

foundation for the country's sustainable development. for citizens' access to information and participation in community life.

RESTORATION PROJECTS: DREAM ANALYTICS**

The Digital Restoration Ecosystem for Accountable Management (DREAM) is a significant milestone in Ukraine's restoration efforts. It's not just a state digital platform for implementing restoration projects but a powerful tool that underscores our unwavering commitment to transparency and accountability.

8954 projects have been added to DREAM since the launch of its beta testing in September 2023. The number of projects by sector includes 3456 projects created in the Education sector 1295 projects created in the Healthcare sector, 977 projects created in the Water, Sanitation, and Waste Management sector, 887 projects created in the Housing sector, 779 projects created in the Transport sector.





*Digital Restoration Ecosystem for Accountable Management (DREAM) is the state digital platform for implanting restoration projects. DREAM collects, organizes, and publishes open data across all stages of reconstruction projects in real time, implementing the highest standards of transparency and accountability.

** DREAM collects, organizes, and publishes open data across all stages of restoration projects in real time, implementing the highest standards of transparency and accountability. As of now, DREAM contains only a part of restoration projects. Legislation ensuring all restoration projects are included in DREAM is being developed.

All the data on projects in DREAM is available on the public <u>portal</u> and via the business intelligence <u>module</u>. At the pilot project stage, the analysis results are not official statistics and may need more accuracy. JAPAN EXPANDS THE ENERGY SECTOR RECOVERY

Ukraine and Japan to expand cooperation in the energy sector



This was discussed during a meeting between Deputy Prime Minister for the Restoration of Ukraine Oleksii Kuleba, and the Ambassador Extraordinary and Plenipotentiary of Japan to Ukraine Masashi Nakagome.

The parties discussed urgent issues of the heating season, the need to restore roads in the frontline regions, the stable functioning of Ukraine's seaports to ensure global food security, and the prospects for the aviation industry.

Deputy Prime Minister Oleksii Kuleba invited Japanese representatives to visit the affected regions to discover the actual needs of the communities. They also discussed the Single Project Pipeline of Investment Projects, which is based on the DREAM ecosystem, and public-private



partnership projects, particularly concession projects in seaports. Oleksii Kuleba emphasized that it is important that all projects are implemented according to the principles of transparency and accountability.

For his part, Ambassador Masashi Nakagome noted that Japan is committed to continuing


and expanding cooperation, particularly in the energy sector. Also relevant is the construction of shelters in schools and the implementation of transport, water supply, and sanitation projects. Representatives of the Japanese side expressed interest in housing projects and business involvement in implementing these initiatives.

The First Deputy Minister of Communities and Territories Development, Aliona Shkrum, invited Japanese businesses to join the URC2025 International Conference on Ukraine's Recovery, which will take place in Rome next June. Alyona Shkrum also noted that housing construction is a social project and an investment project that will attract additional funds to the housing sector. She also said that it is important to continue to work on attracting funding for projects in the water supply, wastewater, and waste management sectors.

In turn, Deputy Minister Maryna Denysiuk spoke about the successful cooperation experience with the Japan International Cooperation Agency (JICA) in implementing pilot projects to install heat pumps at social infrastructure facilities, manage demolition waste, and supply special equipment to the most affected communities. In partic-

ular, Maryna Denysiuk emphasized that it is important not only to transfer the equipment to the balance sheet of the communities but also to ensure its proper use. It is necessary to organize training for operators who can operate this equipment and ensure its necessary maintenance. A separate stream is the supply of power generators to ensure the autonomous operation of critical infrastructure facilities.

The participants also discussed the need to maintain the proper functioning of the aviation sector's infrastructure. The issue of resuming civilian aircraft flights remains open, as it directly depends on the ability to protect Ukraine's airspace from Russian missiles. However, the aviation industry should be operationally ready to resume flights as soon as the security situation allows it. Japanese businesses are also interested in implementing investment projects in the aviation sector.





Masashi NAKAGOME, Ambassador of Japan to Ukraine:

During a telephone conversation yesterday, Prime Minister Ishiba assured President Zelenskyy of Japan's unwavering support for Ukraine. Japan has been actively assisting Ukraine by providing generators, gas turbines, heavy machinery, heat pumps, vehicles, rails, water pipes, and other urgently needed equipment to regions near the front line, and will continue to make every effort to further support with the just approved additional budget of \$190 million. The initiative to establish a Coordination Council for the Reconstruction of Ukraine with the participation of the public and private sectors will help engage the Japanese business sector in rebuilding Ukraine.

THE FINAL MEETING OF THE NATIONAL BARRIER-FREE COUNCIL

Creating a barrier-free society together: the annual final meeting of the National Barrier-Free Council took place



The final meeting of the Barrier-Free Council was headed by Deputy Prime Minister for the Restoration of Ukraine, Oleksii Kuleba, and attended by First Lady of Ukraine Olena Zelenska. The meeting summarized the achievements of 2024 and identified key areas of work for the next year.



As First Lady Olena Zelenska said, the uniqueness of Ukraine's defense is that we are trying to develop without postponing it until after the war. In a UNICEF survey, 83% of Ukrainians named barrier-free accessibility as a new value. In the second wave of the survey, in the fall, this figure was already 87%. At least one in four people in the country has a request for accessibility. That's why it's not about someone, it's always about all of us.

Ministry for Development Communities and Territories of Ukraine presented the results of its work in barrier-free accessibility. Over the year, 895 measures were implemented (89% of the planned number) according to the cooperation of the government, regional and Kyiv city administrations:

- 500 local barrier-free councils established
- 700 communities approved local action plans
- 93,000 facilities tested for accessibility. Only 20% of them meet the barrier-free standards, 32.5% partially meet the standards, and 47.5% remain barrier-free



According to Deputy Prime Minister Oleksii Kuleba, barrier-free accessibility is not just about convenience, but about justice, mutual respect, and national consciousness. It should be the basis of social contract, that should unite communities, all

branches of government, business, and international partners. Barrier-free accessibility should become a philosophy.

STRATEGIC DEVELOPMENT OF THE COMMUNITIES AND TERRITORIES OF UKRAINE

The Ministry of Development has initiated a series of discussions on the strategic development of communities and regions



During December 2024, a series of strategic sessions on "Regional Strategic Planning as an Effective Mechanism for Recovery, Development and Coordination" took place in different parts of Ukraine from Lviv to Kyiv. These was intensive discussions and joint work on the future of the regions with the support of UNDP and financial support from the Government of Japan. The events brought together more than 500 government officials, experts and civil society.

These strategic meetings have become a platform for open dialog and search for optimal solutions for each region. The participants included representatives of regional administrations, local governments, lead-



ing experts in strategic planning and regional policy, members of the Ukrainian Parliament, representatives of the Ministry for Development Communities and Territories of Ukraine, the Ministry of Education and Science of Ukraine, civil society, regional development agencies, and international technical assistance projects. Together, they analyzed the strengths and weaknesses of the regions, identified opportunities and challenges, and most importantly, formed a strategic vision of the future.





The sessions focused on the following key issues:

- analysis of the productive forces of the regions: identifying the unique resources and potential of each region
- assessing the effectiveness of strategic planning: analyzing existing strategies and their relevance to current challenges
- Identification of opportunities and challenges: determination of key factors affecting regional development
- formulation of strategic steps: development of specific action plans to achieve the goals

According to Deputy Minister for Development of Communities and Territories Oleksii Riabykin, regions and communities need to have a clear vision of their future in order to develop. The Ministry pays special attention to strategic planning, as each territory has unique conditions, resources and potential in times of war. It takes into account developing state support programs, stimulating economic activity and creating strategic documents. From 2025 every community and region should have such documents, which are aligned with the State Strategy for

Regional Development. This will allow efficient use of resources at all levels.

The results of these sessions will form the basis for developing effective regional strategies aimed at improving the lives of every Ukrainian and maximizing the efficient use of all resources, including the State Budget of Ukraine.

The strategic sessions were held in Lviv, Cherkasy, Kropyvnytskyi, Odesa, Kamianets-Podilskyi, Kharkiv, and Kyiv and focused on the development of both communities and regions.



EIB PROVIDED EUR 55 MILLION FOR SOCIAL INFRASTRUCTURE RECOVERY

The European Investment Bank (EIB) has provided €55 million in EU-guaranteed financing for the Ukraine Recovery Program to reconstruct hospitals, social housing, educational institutions, heating, water supply and sewage systems, and other critical social infrastructure in 2025 and beyond.



The Ukraine Recovery
Programme is a €340 million
framework loan from the EIB,
supported by an EU technical
assistance grant, to help
communities rebuild vital
social infrastructure.

The Ministry for Development of Communities and Territories of Ukraine implements the program with the Ministry of Finance. Local authorities manage recovery subprojects, while UNDP Ukraine provides technical assistance to accelerate their implementation.

The Ukraine Recovery ProgramIn 2024, several subprojects were completed under the Ukraine Recovery Program, including a water treatment plant in Bucha, Kyiv region, two schools in Vinnytsia region, a children's infectious diseases unit in Zhytomyr region, and now a sewer pressure collector in Zhmerynka, Vinnytsia region.


The sewer reconstruction was completed on December 25, and the total cost of the subproject was EUR 526 thousand. 2.64 km of the sewer pipeline was renewed using durable pipes and modern sensors.

This upgrade guarantees reliable wastewater transportation for the next 50 years, improving sanitation, public health, and environmental protection for more than 33,000 residents of Zhmerynka, including 4,000 internally displaced persons.



Teresa CZERWINSKA, Vice-President of the EIB:

Together with our EU partners, the European **Investment Bank supports** Ukraine's recovery and reconstruction. This €55 million tranche for the Ukraine Recovery Program will help communities rebuild critical infrastructure, including schools, hospitals, heating systems, housing, water and sanitation facilities, and other essential services for citizens. Ukraine continues to rebuild despite the challenges of war, and we are pleased to support these efforts.
